  assistance– 4 biologists. Ms. Aimar also updated on other work including:

- Grasshopper Sparrow: Habitat analysis complete data analysis in progress.
- Exotic fish removal: 4 biologists assisted SBVMWD in upper SAR.
- Herps: Potrero ACEC Herp array's surveys in progress.
- Mammals: Long-tailed weasel track plate surveys in progress.
- Clinton Keith Overcrossing: Camera traps at overcrossing and nearby underpass for carnivores.
- Delhi Sands Flower-loving Fly: Presentation at SAR Science Symposium.
- Taxa Leads collaborating with MSHCP Natural Resources Manager to share information regarding RCA-owned lands with sensitive habitats and species.
- Interim Administrator hosted monthly monitoring/management coordination meeting (Oct.) with local land managers and wildlife agency representatives.
